

**INFORMATION CLAUSE CONCERNING THE PROCESSING OF PERSONAL DATA BY THE
OCALENIE FOUNDATION - ISSUING SCHOOL UNDER A PROJECT CO-FINANCED BY CARE
AND SUPPORTED BY THE MUNICIPALITY OF WARSAW AND MINISTRY OF FAMILY AND
SOCIAL SUPPORT**

Pursuant to Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation (GDPR)) we wish to inform you that:

1. The administrator of personal data is the Ocalenie Foundation, located in Warsaw, 00-537, at ul. Krucza 6 / 14a. NIP: 118-157-02-03; KRS: 0000030279; REGON: 016446315, represented by the Management Board.
 2. The basis for the processing of personal data is: art. 6 sec. 1 letter e) of the GDPR - performance of a task in the public interest resulting from the statute of the Ocalenie Foundation and art. 6 sec. 1 letter f) of GDPR - legitimate interests of the Administrator, incl. Administrator's defense against possible claims.
 3. The personal data provided will be processed in order to handle the process of issuing school starter kits for children, as well as to defend the Administrator against potential claims and handle complaints.
 4. Personal data may be made available to other entities only in connection with the implementation of the objectives set out in point 3. The recipients of personal data may be:
 - authorized employees of the Administrator;
 - service providers entrusted with the processing of Personal Data for the purposes of providing services for the Administrator, their authorized employees - to the extent necessary for the proper performance of these services;
 - entities authorized to receive personal data on the basis of legal provisions;
 - institutions funding the project, solely for reporting purposes.
 5. The data owner has the right to:
 - requests from the Administrator to access their personal data, rectify them, delete or limit the processing of personal data,
 - object to processing of data,
 - transfer data,
 - file a complaint to the supervisory authority.
- In order to exercise his/her rights, the data owner may contact the Foundation at the correspondence address provided in point 1 or by e-mail at dane@ocalenie.org.pl.
6. Personal data will be processed for the period of using the assistance of the Help Center for Foreigners, and from the end of the calendar year in which we recorded the last contact with you - until any claims related to the use of the Help Center for Foreigners are time-barred and, in justified cases, as required by law or funders, i.e. in principle not longer than 10 years.
 7. Personal data is not subject to automated decision making, including profiling.
